- ii. Evidence of current tax clearance for the last three (3) years (2020, 2021 & 2022) valid till 31st December, 2022.
- iii. Evidence of current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2023.
- iv. Evidence of Pension Clearance Certificate valid till 31st December, 2023.
- v. Evidence of Current Nigeria Social Insurance Trust Fund (NSTIF) Clearance Certificate valid till 31st December, 2023.
- vi. Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) valid till 31st December, 2023 or valid Certificate issued by BPP.

- ix. Evidence of financial capability to execute the project by submission of reference letter from a reputable commercial bank in Nigeria indicating the wiliness to provide credit facility for the execution of the project when needed.
